5. Evaluation

Students will be asked to choose as between one of the proposed cases, identify the main legal issue(s), analyze it (or them) according to the Spanish Law of Torts, and provide one or more grounded conclusions. Student will have 2 hours to complete this examination.

25%:

- Students are required to submit 1 essay (1.500 words) about a global case, which will be discussed in seminar 3 (week 10). Deadline for submission of this essay: week 10 in seminar 3. Value: 15%

- Seminars 1 and 2 will consist on the discussion of cases and problems. Participation in each seminar will be evaluated (10%).
