1. Introduction of the subject

Students who graduate and begin their careers will be part of organizations, and will either manage or be managed. In this introductory class, the students will learn the key concepts to make sense of their professional environment. They will learn about the manager's role, the importance of organizational culture, the basics of how decisions are made in organizations, how work is organized and coordinated, how human resources are managed. They will also learn about issues related to motivation, control, as well as interpersonal relations.

The theory is taught in class and through assigned readings. Students learn to be familiar with the concepts during class discussion, and by working on individual and group assignments.

Reading, understanding and reflecting on the reading assignment is crucial to successful completion of the course.

4. Evaluation

- <u>1rst trimester:</u> 50% seminar 50% final exam*

-Final grade of business organization and management I (first + second trimester):

- It is not necessary to get a minimum grade for being applicable to the final average. That means that if, for instance, a punctuation of 7 has been obtained in the first trimester and a punctuation of 3 has been obtained at the second trimester, the final grade will be 5.

-September exam:

- If the weighted average of the two trimesters is below 5, the final exam will comprise the content of the two quarters.

6. Methodology

Theory lectures (18 lectures of 1 hour and 30 minutes each one) will consider the main theoretical issues. These were illustrated by practical examples, and more specifically by using newspaper articles. Class participation is encouraged and short discussions are generally held.

Seminar sessions (5 lectures of 1 hour and 30 minutes each one) are devoted to the discussion of case studies and to the supervision of group work.

In the first trimester the focus of the seminars will be on the application of the class concepts to short case studies / discussion of timely issues.

In the second trimester, there will be a group project. Seminar time will be devoted to the supervision of the group projects. All groups will have to report the status of their work by giving short oral presentations to report on the status of their projects, and will have the opportunity to ask for advice/feedback.

PDA – Business Organization and Management I

This course includes the possibility of scheduling "aules obertes", where professionals are invited to deliver a lecture about a topic related with the course. The amount and the scheduling will depend on the speakers' availability and agenda. We might invite outside speakers outside of regular teaching ours (early evening sessions – to accommodate speakers' schedules). In this case, attendance will be encouraged, but optional.

7. Regulation for the courses imparted in English.

- All the subjects imparted in English should be developed by lecturers that choose to do so by own initiative. Once chosen English as a teaching Language for a given group, it must be respected the use of this Language in the lectures, bibliography and exams.

-With regards to the use of the English Language at the exams, it has been established that:

- At the bachelor in business management the way to proceed will be following one:
