## **Syllabus**

This subject is a study of the system for protecting fundamental rights in the Spanish legal system. It includes an analysis of the mechanisms provided for in the 1978 Spanish Constitution to protect fundamental rights, their legislative development and the impact on the Spanish legal system of European and international systems for the protection of human rights.

On completing the course students will know and understanding the concept and fundamental ideas of what is meant by human rights, their relationship with constitutionalism and the international human rights movement. They will also know and understand the mechanisms of protection and guarantee provided for in the 1978 Spanish Constitution and their interrelation with European systems for the protection of fundamental rights. Finally, students will acquire essential knowledge of the content of the fundamental rights recognised in the Spanish legal system. To follow the course students need to develop skills related to the ability to understand and analyse constitutional texts, both past and current, constitutional case law and doctrinal articles, as well as the capacity to apply the structures of constitutional argument to conflict resolution and the critique of institutions.
